1. Member Secretary apprised that

- i. Efforts are being made for filling up of various vacant posts, however, two Nursing Officers and one Lab Assistant has joined.
- ii. Waiting time for various surgical units has been reduced to less than one month.
- iii. Renovation of physiotherapy room has started.
- vi. Demand of 5 CCTV Cameras will be sent to Sh. Vishesh Ravi, Hon'ble MLA (Karol Bagh).
- v. Efforts are being made for parking space.
- vi. As per Orders of the Health & Family Welfare Department, GNCTD OPD hours of the Hospital has been changed to Registration from 7:30 A.M. to 12 Noon and OPD from 8:00 to 2:00 P.M.
- 2. Member Secretary apprised that PAC & OT is suffering as Anaesthetist, Dr. Soni Pandey has been detailed to Bhagwan Mahabir Hospital, GNCTD and Dr. Daljeet Kaur is detailed to Sardar Vallabh Bhai Patel Hospital, GNCTD on Monday & Tuesday.

3. Assistant Engineer (Electrical), PWD assured that he will submit the estimate within one week for installation of Solar System in Hospital.
